

STALLION SERVICE CONTRACT

This service is subject to the following:

1. A non-refundable booking fee of \$ _____ is payable when contract is signed and returned to Stallion Manager. This fee is part of the total stallion fee.
2. It is agreed that the Stallion Manager may check the above mare for normal breeding conditions and perform such other veterinary services for the mare (and foal) as is deemed necessary at the expense of the Mare Owner. This includes worming, treating for infections, preventative measures, examinations, diagnostics, ultrasounds, etc., as may be necessary.
3. All board, shoeing, trimming, and veterinary charges are payable monthly and are in addition to the stallion fee.
4. The Stallion Manager agrees to diligently try to settle the mare named above until June 15th. The Stallion Owner will guarantee a live foal, but, if for any reason the mare does not settle, the Stallion Owner and Manager shall be held harmless. In the event the mare fails to settle, no breeding fee will be charged except the booking fee.
5. Should the mare abort or not have a live foal that stands and nurses, this mare will have a return privilege for the next year breeding season, providing the Stallion Manager receives notification, accompanied by a statement from a licensed veterinarian, within one week of occurrence. If a Mare Owner fails to deliver this mare for breeding the following year, then any and all fees shall not be refunded and the return privilege for breeding cancelled. Another mare may be substituted upon mutual agreement of Mare Owner and Stallion Manager. Veterinarian services will be charged on a return breeding.
6. Should the stallion in this contract die or become unfit to breed, or if the mare named above should die or become unfit to breed prior to natural or artificial insemination of the mare, then this contract shall become null and void and all money paid toward the stallion fee shall be refunded.
7. It is understood and agreed that the Stallion Owner and Manager will not be responsible for any disease, accident, sickness or death of the mare or her foal and the Stallion Manager will exercise his best judgement in supervising and caring for them.
8. A photostatic copy of the mare's registration papers shall be furnished prior to or upon arrival of mare.
9. One (1) Stallion Service Certificate will be issued to the Mare Owner upon request at any time after the mare or recipient is pronounced in foal and all amounts due to Fales hereunder have been paid in full.
10. All amounts due from the Mare Owner which are unpaid after thirty (30) days from the date due will bear interest at the rate of one and one-half percent (1½%) per month / eighteen percent (18%) per annum.
11. When this contract is signed by the Stallion Manager and the Mare Owner / Agent it will be a binding contract on both parties and subject to the above terms and conditions.
