

TRANSPORTED SEMEN STALLION SERVICE CONTRACT

This service is subject to the following:

1. A non-refundable booking fee of \$ _____ is payable when contract is signed and returned to Stallion Manager. This fee is part of the total stallion fee.
2. The balance of the breeding fee \$ _____ and all other fees must be received before delivery of semen. A photocopy of the registration papers must accompany the return of this contract.
3. The Stallion Manager assumes responsibility to deliver live semen in viable condition at the time of delivery to the Mare Owner's farm or breeding station. The semen must be administered by a licensed veterinarian on the day of delivery or the Stallion Manager and Owner shall be considered to have fulfilled the contractual obligation and any guarantees shall not apply.
4. Should the mare fail to conceive, abort, or not have a live foal that stands and nurses, this mare will have a return privilege for the next year breeding season, providing the Stallion Manager receives notification, accompanied by a statement from a licensed veterinarian, within one week of occurrence. If a Mare Owner fails to request the breeding the following year, then any and all fees shall not be refunded and the return privilege cancelled. Another mare may be substituted upon mutual agreement of Mare Owner and Stallion Manager.
6. Should the stallion in this contract die or become unfit to breed, or if the mare named above should die or become unfit to breed prior to the shipment of semen, then this contract shall become null and void and all money paid toward the stallion fee shall be refunded.
6. It is understood and agreed that the Stallion Owner and Manager will not be responsible for any disease, accident, sickness or death of the mare.
7. One (1) Stallion Service Certificate will be issued to the Mare Owner upon request at any time after the mare or recipient is pronounced in foal and all amounts due to Fales hereunder have been paid in full.
8. If the breeding results in more than one pregnancy of any combination of the mare, recipient or recipients, the Mare Owner hereby agrees to (a) notify the Fales within 48 hours of such event that more than one pregnancy has occurred and (b) that the Mare Owner shall not be entitled to receive more than (1) stallion service certificate.
9. It is understood that the above stallion will have semen available on scheduled breeding days only from February 1st thru June 15th of the breeding year unless otherwise noted.
10. All amounts due from the Mare Owner which are unpaid after thirty (30) days from the date due will bear interest at the rate of one and one-half percent (1½%) per month / eighteen percent (18%) per annum.
11. When this contract is signed by the Stallion Manager and the Mare Owner / Agent it will be a binding contract on both parties and subject to the above terms and conditions.
